

Introduction


SABREJET! — That word instantly brings to mind thoughts of silver swept wing jets locked in mortal combat in the skies over Korea. But the North American Aviation (NAA) F-86 Sabre was much more than that. Not only was it the best clear-air fighter in the world at that time, the basic design would evolve into the only production single seat all-weather jet interceptor, an atomic capable fighter-bomber and a carrier-based fleet interceptor and fighter-bomber for the Navy. The F-86 series was built by many different manufacturers throughout the Free World and served to counter the Soviet threat during the 1950s.

The F-86 Sabre was just one of the superb designs to come from North American Aviation. During the 1940s and 1950s North American literally "owned" the military aircraft sales market, not just in America, but throughout the Free World. This aviation giant began life as a holding company in the early 1930s with no designs of its own. Originally founded in 1928, the company was reorganized in 1933 with James H. "Dutch" Kindelberger as President. Under Kindelberger, NAA entered the military aviation business.

The first NAA design was the O-47 observation aircraft. This was followed by a single engine, monoplane basic trainer, the BT-9 which evolved into the greatest trainer aircraft of the Second World War — the T-6 Texan. The BT-9/T-6 contract made it possible for NAA to move to a new North American Aviation plant in Inglewood, California in January of 1936. The 159,000 square foot factory was located at the south edge of Mines Field (Los Angeles International Airport).

During the Second World War, NAA produced two of the war's finest combat aircraft. The first was the famed B-25 Mitchell and the second aircraft was the "most perfect pursuit plane in existence" — the P-51 Mustang. At the peak of wartime operations, NAA employed over 91,000 people. The factory had grown into two huge complexes with over

Project drawings were for a proposed compound piston/jet variant of the P-51 Mustang with a forward swept wing. (NAA)




8,573,835 square feet of floor space. Between 1 January 1939 and 30 September 1945, NAA built 42,683 military aircraft including 15,603 P-51s, over 15,400 T-6s and 9,817 B-25s (some 14 percent of all U.S. aircraft production).

An incident midway through the war made the Mustang obsolete, along with every other combat aircraft in existence. That incident was the operational debut of the German jet-powered Messerschmitt Me-262. With two Jumo jet engines, the Me-262 had a speed of over 550 mph, some 125 mph faster than the best Allied fighters. By early Fall 1944, Me-262s were defending the Reich, taking the Allies by surprise.

The rush to catch up saw jet aircraft design proposals come in from every U.S. company. Bell Aircraft was the first to have a jet fighter aircraft flying. The P-59 Airacomet, however, was not a successful combat aircraft: it was not as fast as the Mustang or Thunderbolt and could not hope to match the Me-262. Lockheed and Gloster fielded jet fighters and both the Lockheed P-80 and the Gloster Meteor did see some combat in the Second World War, but neither was a counter to the Me-262. Three other companies submitted design proposals to the War Department: Republic (XP-84), Grumman (XF9F) and North American (XP-86).

NAA had been interested in jet powered aircraft for some time, with the Confidential Design Group making an initial proposal for a jet fighter in early 1943. Ed Schmued had one design based on a piston/turbojet powered P-51 with a radical forward swept wing. One of the design studies from North American was selected by the Navy as its first jet fighter aircraft, the XFJ-1 Fury. The XFJ-1 used a circular fuselage that enclosed a GE J35 jet engine. The intake was in the nose with a straight through duct to the engine, rather than using side inlets such as those found on the P-80 and XF9F. The wing and tail were similar to the P-51 Mustang and armament was six .50 caliber machine guns. The contract for the first XFJ-1 Fury was let on 1 January 1945.

The original XP-86 design was quite similar to the XFJ-1 Fury. The XP-86 fuselage was more slender and longer than the Fury, but it retained the wing and tail surfaces of the XFJ-1. Both the XP-86 and the XFJ-1 were powered by a 4,000 lbst General Electric J35 axial flow turbojet. The straight wing and the low thrust of the J35 restricted the XP-86 to a top speed of some 575 mph — far below what the USAAF requirement called for.



The end of the Second World War brought an immediate (and controversial) influx of jet technology from Germany. As rapidly as advances were made in engine technology, however, the speed potential seemed to stabilize at about 600 mph. Something was needed to bring airframe technology in line with the power plants. Captured German documents, translated by Larry Green, NAA's Head of Design Aerodynamics, including transonic wind tunnel data, clearly showed the speed benefit of swept wing surfaces.

In September of 1945, NAA engineer Harrison Storms studied the results of Green's research and thought it might be incorporated into the XP-86 proposal. The German wind tunnel tests revealed compressibility drag was delayed through the use of swept wings. Storms' swept wing XP-86 was estimated to be about 75 mph faster than the straight wing XP-86. There were problems with the use of a swept wing including a loss in low speed handling characteristics, but a further study of German research revealed that movable leading edge devices, called slats, that extended into the airstream improved low speed handling.

Storms' new wing with its 35 degree sweep and full span leading edge slats was fitted to the redesigned XP-86 model and tested in NAAs low speed wind tunnel. The swept wing exhibited satisfactory stall characteristics when fitted with the leading edge slats and gave the XP-86 an estimated top speed of over 650 mph. As a result, the USAAF

authorized three prototypes in November of 1945.

The first XP-86 prototype (45-59597) took slightly over eighteen months to complete and rolled out at NAA's Inglewood plant on 8 August 1947. The prototype emerged as a sleek low wing aircraft with swept back wings and tail surfaces, with little resemblance to its contemporaries, such as the P-80, P-84 and F9F. Not only was the airframe a radical departure from any other aircraft then in production, the XP-86 also incorporated two major structural innovations. First was the use of tapered skinning and the second was the use of a double skin structure rather than a conventional rib and stringer construction. This provided added strength and allowed enough open area in the wing for fuel tanks.

The XP-86 looked fast — and it lived up to its looks. After extensive ground testing, NAA test pilot George "Wheaties" Welch lifted the XP-86 off the dry lake bed at Muroc on 1 October 1947. Flight tests revealed that the XP-86 was all that the Air Force had hoped for. The greatest advantage of the swept wing was its low drag at high Mach numbers.

The swept wing XP-86 rolled out on 8 August 1947 and NAA test pilot, George "Wheaties" Welch made the first flight with the XP-86 from Muroc Dry Lake on 1 October. The prototype carried no armament. (NAA)

This meant that thrust that was needed to reach these speeds with a straight wing aircraft could now be used for combat maneuvering. It was found that the swept wing actually had a higher lift factor than a larger straight wing design at high Mach numbers. This meant that a Sabre pilot could keep the Mach number high in a diving turn where lift is usually a limiting factor with a straight wing. The XP-86 was designed with a set of speed brakes in the rear fuselage, two on the fuselage sides and one, large brake under the fuselage. These brakes could be opened in any attitude and speed, including at or above Mach One. No other fighter had such a braking system.

Tests showed that the XP-86 was 75 mph faster than anything else in service. The XP-86 wasn't just a fast aircraft. The leading edge slats could be used to lessen turn rate and gain an advantage over an enemy. It was a "pilots airplane." If the XP-86 went out of control, the pilot need only to release the stick and the XP-86 would stabilize, if you had the altitude. One of the things pilots liked about the airplane was the great vision through the

360 degree bubble canopy.


Low speed handling, especially during takeoff and landing was still an area of concern, even with full extension of the leading edge slats. If the wing lost lift, no amount of power could keep the XP-86 airborne. The aircraft would perform what was known as the "Sabre dance," during which the aircraft would flounder in the air, waving back and forth on its exhaust plume, usually with fatal results. The answer was more power and North American re-engined one of the three XP-86 prototypes with the new 5,200 lbst J47-GE-3 power plant (which was intended for production aircraft) and it was this XP-86 that "Wheaties" Welch put through the sound barrier on 25 April 1948. With the successful completion of the test program, the Air Force ordered the aircraft into production under the designation F-86A Sabre.


F-86A

The installation of the J47-GE-1 engine was the main difference between the XP-86 prototype and the F-86A production aircraft. The J47-GE-1 engine was rated at 5,200 lbst, compared with the 4,000 lbst available with the J35 engines used in the XP-86s. Installation of the J47 brought the performance of the F-86A-1 into the transonic region, with a top speed of over 670 mph. MAJ Robert L. Johnson exhibited this performance when he set a new World Speed Record of 670.98 mph in a production F-86A-1 on 15 September 1948.

Externally the production F-86A differed only slightly from the XP-86 prototypes. The F-86A-1 was armed with six .50 caliber machine guns which had not been installed on the XP-86. The guns were in three-gun packs installed on each side of the fuselage nose. The gun ports were covered with electrically operated doors for aerodynamic streamlining and opened inward whenever the guns were fired. The F-86A was outfitted with an ejection seat so that the pilot could safely leave a crippled F-86 at high speeds. The underfuselage dive brake was eliminated and the fuselage speed brakes now opened rearward instead of forward as on the XP-86s.

The F-86A-5 was the first combat-capable variant. It differed from the F-86A-1 in having a V-shaped, armored glass windscreen and heated gun compartments. It also was the first F-86 equipped with an underwing pylon capable of carrying a variety of ordnance, including 500 and 1,000 pound bombs and underwing fuel tanks of up to 206 gallons. Additionally the F-86A-5 could carry 5 inch HVAR rockets on stub launchers under the wings. Power was upgraded through the installation of the -7 engine and later the -13 engine. Both were still rated at 5,200 lbst, but they were more reliable and easier to maintain.


Most of the thirty-three F-86A-1s were used for test and evaluation purposes and it was the F-86A-5 that was the first to see squadron service. The 1st Fighter Group at March AFB was the first operational unit, transitioning from Lockheed F-80s to the F-86A-5 during February of 1949. The 1st FG was charged with the air defense for the Los Angeles area, which included the North American plant where their aircraft were built. The next fighter groups to become operational with the F-86As were the 4th FG at Langley AFB which defended the nation's capitol and the 81st FG at Kirtland AFB, that covered the atom bomb plant at Alamogordo, New Mexico. In all, five USAF fighter groups were equipped with F-86As. The Air Force accepted 554 F-86As at a cost of \$178,408.00 each. The first Sabres that went to reserve units were assigned to the 116th FIS/Washington ANG which transitioned to F-86As on 22 December 1950.

Of the five operational groups, it was the 4th Fighter Interceptor Group that became the most famous and it was the 4th that took the Sabre to war. When the Communist Air Forces introduced the MiG-15 into the air war over Korea in November of 1950, they immediately made all the fighter aircraft that the 5th Air Force had in the theater obsolete. The MiG could easily gain air superiority anywhere they chose to appear. The B-29 force was helpless against MiG attacks and 5th AFF-80 Shooting Stars could do little to stop the MiGs from getting the B-29s. The MiG was almost 75 mph faster than the F-80C. Had the Red generals moved the MiG force into Korea behind their successful ground offensive in the Winter of 1950, it would have made things much more interesting.

But they didn't and FEAF countered the MiG threat by asking for, and receiving the best aircraft available in the U.S. inventory — the F-86A-5 Sabre. The Air Force immediately dispatched the 4th FIG to Korea with their F-86As. After a long sea voyage aboard Navy ships, the 4th FIG put seven F-86As from the 336th FIS into operation at Kimpo Air Base (K-14), Korea on 13 December 1950. Flying an uneventful first mission on 15 December, the Sabres drew first blood on 17 December, when Baker Flight, led by LCOL Bruce Hinton, jumped a flight of MiGs near Sinuiju. LCOL Hinton shot down

one of the MiGs for the first Sabre victory of the Korean War. It would not be the last, as Sabre pilots would rack up 791 more MiG victories before the end of the Korean Police Action in July of 1953.

There were several modifications made to the F-86A during its service life. Problems in Korea led to a replacement of the Mk 18 gyroscopic gunsight with an A-1CM sight that was linked to the AN/APG-30 radar built into the lip of the nose intake. Several model 48 F-86As that were in Korea with the 4th Fighter Interceptor Wing were converted to reconnaissance aircraft. The aircraft were flown to the Rear Echelon Maintenance Facility (REMCO) at Tachikawa, Japan for Project ASHTRAY. The ASHTRAY conversion included the removal of the gun system and ammunition supply bays and installation of a pair of K-24 cameras housed in a bulged fairing under the fuselage where the ammo bays had once been.

The cameras were mounted on a horizontal axis, which aimed them at a mirror for vertical coverage. The mirror mounting was quite crude and flimsy and many of the photos came out blurred due to camera and/or mirror vibration. But overall the project was a success. Any photo mission into or near "MiG Alley" was flown by one of the ASHTRAY RF-86As, which were painted exactly as their 4th FIW fighter cousins across the field at Kimpo. By the end of the war at least seven aircraft had been modified to RF-86A standards. Several had a "dicing" camera fitted in the lip of the nose where the gunsight radar had been mounted. These cameras were covered with small sliding doors. Some RF-86As retained two of their .50 caliber guns (with a very limited amount of ammunition) for self-defense. Although the RF-86A project was a field modification done for a combat requirement (and strictly a temporary design until RF-84Fs could be delivered) North American did build several RF-86Fs strictly for use in Korea. All the RF-86 Sabre missions in Korea were flown by 15th TRS pilots.

F-86B

The F-86B was a modification of the original F-86A with larger wheels, tires and heavier brakes which would have meant an additional seven inches added to the width of the fuselage. Air Force signed a letter of intent to buy 190 F-86Bs during 1947; however, tire and brake technology advanced to such a point that the original tire/brake size requirements were retained and the order was altered to 188 F-86As and two F-86Cs. No prototype F-86Bs were ever built.


The first operational unit to re-equip with F-86As was the 1st Fighter Group at March AFB, California which received their first Sabres in March of 1949. The rounded windscreen was only used on the F-86A-1. To maintain streamlining, the gun ports for the .50 caliber machine guns were covered by automatically opening doors. (USAF)

Nose Development

When the Cold War heated up, the USAF transferred the F-86As of the 81st FIG to bases in England during August of 1951. 

F-86C/YF-93A

The F-86C was designed around a requirement for a long range fighter aircraft to escort SAC bombers to Soviet targets. It retained the swept wing planform of the F-86A Sabre but had an entirely new fuselage and engine. Power for the F-86C was to have come from a 8,000 lbst Pratt & Whitney J48-P-1 engine with an afterburner. The larger J48 engine meant that the fuselage had to be enlarged both in width and length. The F-86C was forty-four feet long, some six and a half feet longer than an F-86A and much wider. The immense fuselage was fitted with additional fuel tanks that brought the total fuel capacity to 1,580 gallons.

The F-86C was armed with six 20MM cannons and had an SCR-720 search radar housed in the nose radome. With the nose now housing the radar, the F-86C had the air intakes repositioned to the sides of the fuselage using NACA-designed recessed air scoops. The fuselage also utilized the new area rule "coke bottle" shape. This pinched or "Wasp waist" design reduced drag at high Mach numbers and would be used on most of the Century Series fighters during the 1950s. The dive brakes were replaced by a large slab brake mounted under the fuselage (very similar to that found on the later F-100).


Late in their service lives, both YF-93As were modified with standard protruding air intakes over the NACA flush intakes. The aircraft retained the F-86A wing, tail assembly and V-shaped windscreen. (NAA)




All these changes to the airframe led the Air Force to redesignate the aircraft the YF-93A. Rollout of the YF-93A came in late 1949, with the first flight taking place on 24 January 1950. The weight of the YF-93A was over 26,500 pounds in combat trim, almost twice that of the F-86A. But the 8,000 lbst J48 engine, combined with all the low-drag design features, led to a surprising top speed of 708 mph. Range on internal fuel was almost 2,000 miles, compared with a ferry range of 1,052 miles for the standard F-86A (with external fuel tanks).

Two YF-93As were built (48-317 and 48-318) and late in their service lives, both YF-93s had their air intakes redesigned with a conventional protruding scoop extending over the NACA flush intakes. The YF-93A was used to compete against the Lockheed F-90 for the role of "penetration fighter" to escort SAC bombers to Soviet targets. But development of long range jet bombers, the B-47 and B-52, with their very high speed, eliminated the need for a penetration fighter. As a result, both fighter projects were cancelled and the funds used to purchase more bombers. At some point in their service with NACA, both YF-93As had the rear fuselage modified to accept a production F-86D tailpipe and stabilizer housing. The YF-93As were used by NACA as flight test and chase aircraft well into the mid-1950s.

Fuselage Development







The F-86C/YF-93A was a North American Aviation project designed to create a long range, penetration jet fighter using existing Sabre technology. The F-86C/YF-93A used an 8,000 lbst Pratt and Whitney J48-P-1 engine with afterburner, had large side mounted NACA-designed flush air intakes and a dual wheeled main landing gear. (NAA)

F-86D

During 1949, the Air Force issued a requirement for an all-weather jet interceptor. Several manufacturers responded with formal proposals but North American's was easily the most radical. While all the other all-weather jet proposals were two seat aircraft with a pilot and radar intercept officer, the North American proposal combined the roles through the use of something radically new called a flight control computer and the concept of the "one-man interceptor" was born. While the flight control computer flew the aircraft and monitored the engine and flight controls, the pilot flew the Hughes E-3 Fire Control System to complete the intercept. When it worked correctly, it was a very good and workable system.

The computerized controls weren't the only things different about the F-86D. The F-86D was the first fighter aircraft armed solely with air-to-air rockets in place of machine guns or cannons. The twenty-four 2.75 inch Folding Fin Aircraft Rockets (FFAR) were loaded in a retractable tray in the underside of the fuselage just behind the nose landing gear well. When the pilot pulled the trigger, the tray instantly extended into the airstream and

fired the correct volley of rockets.

The F-86D also differed from the earlier F-86A in the power plant. The earlier 5,200 lbst J47-GE-1 engine was replaced with a 7,500 lbst afterburning J47-GE-17 engine. All these changes left only about twenty-five percent of the original F-86A and the Air Force decided to redesignate the aircraft as the F-95A. Strangely, the F-95A/YF-86D had serials numbered after the beginning of the production run (the F-95As were numbered 50-577/578 and production began with the F-86D-1 50-455). Although some 2,500 pounds heavier than the F-86A, the F-86D was actually faster and the F-86D broke the World Speed Record twice within a year. CAPT Slade Nash broke the previous record when he went 698.5 mph in November of 1952. This record was short-lived and LCOL William Barnes broke the record in July of 1953 with a speed of 715.6 mph.


Use of the Hughes E-3 Fire Control System, AN/APG-36 search radar with its thirty inch radar dish and afterburning J47-GE-17 engine, necessitated the use of a completely redesigned fuselage. The new fuselage differed from the F-86A in that it was some three feet longer and was somewhat deeper and wider. The air intake was moved under the radome and was much wider than the F-86A intake. Although the first prototype had the standard F-86A sliding canopy and windscreen, production F-86Ds used a clamshell opening canopy. The F-95A/YF-86D retained the wing with leading edge slats, landing gear, dive brakes and basic flight controls of the F-86A.

One major change in the flight controls was the use of an all-flying tail unit. The horizontal stabilizer and elevators were combined in a single "slab" stabilizer and this entire "slab" moved, giving much greater elevator control. It meant that the pilot retained normal control of the aircraft in the transonic/supersonic speed range instead of suffering control reversal, common to aircraft having a standard stabilizer/elevator control system.

Throughout its service life, the F-86D was constantly upgraded, especially in its electronics. The F-86D-5 introduced the Hughes E-4 Fire Control System. The D-25 had provision for drop tanks. The D-35 had an omni-directional ranging radar. The D-45 introduced a drag parachute to aid in stopping the F-86D on short runways. The D-60 was powered by a 7,950 lbst J47-GE-33 engine. The final upgrade was the most radical and resulted in a new designation — the F-86L.

F-86L


The F-86L was not a new production aircraft but rather a rebuild of existing F-86D airframes modified with several totally new systems. The wing was replaced with a longer-span, slatted wing (then in use on the F-86F-40), all the electronics were brought up to the latest "state of the art" technology, including stripping the entire aircraft of its existing wiring and replacing it with all new wiring. A new electronic data-link between the air defense ground controller and the pilot was added to the aircraft. It was known as the SAGE system (Semi-Automatic Ground Environment). The SAGE equipment allowed the interceptor pilot instant access to any and all information available from the ground controller. SAGE equipment included an AN/ARR-39 data link receiver, AN/ARC-34 command radio, AN/APX-25 identification radar and a new glide slope receiver. The SAGE antenna under the forward fuselage was the main external difference between the F-86D and F-86L.

The SAGE equipment was tied into the E-4 Fire Control System and automatically computed the proper lead-collision attack course. These modifications were conducted under Project FOLLOW ON at the North American facilities at Inglewood and Fresno, California. The first flight of the F-86L took place in late Spring of 1956, with the 49th FIS taking delivery of the first operational F-86L in October. The Inglewood plant modified 575 late production F-86Ds (the last F-86D came off the assembly line in September of 1955) to F-86L standards, with the Fresno plant doing an additional 452 aircraft. The Air Force accepted a total of 827 F-86Ls by the time the program ended.

The F-86D quickly became known in the Air force as the "Sabre Dog." The F-86Ds flew air defense missions throughout the world with USAF units active in Europe and the Far East. Serving alongside Lockheed F-94 Starfires and Northrop F-89 Scorpions, it was the "one-man interceptor" from North American that was clearly the first choice for the Air Force. Of the thirty squadrons that comprised the Air Defense Command during the mid-1950s, twenty were equipped with F-86Ds!


F-86Ds and F-86Ls were also put into the Military Assistance Program and served with a number of friendly foreign air forces. Denmark purchased sixty F-86Ds between 1958 and 1960 assigning them to Nos 723 and 726 Eskadrillerne. Denmark was the only NATO air force to be equipped with F-86Ds. Four SEATO air forces were equipped with F-86Ds — South Korea, Japan, Nationalist China, and The Philippines. The Royal Thai Air Force purchased F-86Ls as they became available. The USAF Air National Guard equipped twenty-six air defense squadrons with F-86D or L aircraft. The last F-86D/L mission was flown by the 196th FIS/California Air National Guard during mid-1965, just before they transitioned into supersonic Convair F-102As.

















F-86F

The F-86F was the ultimate clear air, day fighter variant of the Sabre. It was built in four basic sub-types — narrow chord wing with Leading Edge Slats (LES), "6-3 wing" with fences, with atomic capabilities, and with extended span wings with LES. One of the biggest gripes that combat pilots in Korea had about the Sabre was its lack of engine power. It was a great flying aircraft and very safe with its armored cockpit and backup systems. But all these safety additions meant added weight and added weight meant a decided disadvantage with the MiG in rate of climb and service ceiling. As a result, General Electric began a development program with the non-afterburning J47 which resulted in the 5,910 lbst J47-GE-27 engine. The increase in power raised the rate of climb to 9,300 ft/min. Although still less than the MiG-15, it did make the Sabre pilots more competitive against the Soviet fighter. Top speed also increased with a sea level speed of 693 mph. With the F-86F-10, a new A-4 radar ranging gunsight was added to the fire control system.

The F-86F-25 variant is regarded by many as the ultimate day fighter of the early 1950s. Initially the F-86F-25 and -30 were simple modifications with an additional hard point added to each wing for carriage of a second drop tank or 1,000 pound bombs. But in August of 1952, North American Aviation engineers tested a new wing design. The wing chord was extended six inches at the root and three inches at the wingtip. The extension was done on the wing leading edge and, at the same time, the leading edge slats were removed and replaced with a fixed leading edge. A small wing air flow fence was also added to the wing (approximately seventy percent of the span). This fence helped guide airflow over the wing and reduced transonic buffet. The result — a tighter turning radius at high Mach numbers.

Sabre pilots now had an aircraft that could easily out dive the MiG, could now turn with and inside the MiG and had almost as great a rate of climb. The MiGs still had an altitude advantage, which saved a lot of them from destruction in Korea. With all the other advantages the Sabre pilot had (self-sealing fuel tanks, armored cockpit, radar gun sights and much better training) — the result in combat was predictable. In May and June of 1953, Sabre pilots, most of them flying new F-86Fs, shot down a total of 133 MiGs for the loss of one Sabre. Most of the credit has to go to the Sabre pilots who took full advantage of all the new modifications to the aircraft.

The final two major day-fighter sub-variants were the F-86F-35 and F-86F-40. The F-35 featured the Low Altitude Bombing System (LABS) which was capable of "loft-bombing" a small atomic weapon. The F-86F-40 was a development for the Japanese Air Self Defense Force which featured the 6-3 wing. The 6-3 wing was fitted with leading edge slats and a one foot extension at the wingtip. The longer wing with slats made for a very stable aircraft at low speeds, which was needed for all the Military Assistance Program pilots from nations all over the world that were going to be equipped with Sabres of various types. This F-40 wing was also adopted by the USAF for the Sabres used at the Nellis AFB Fighter School for training both U.S. and foreign pilots.

At the peak of their service, the USAF had sixteen wings equipped with the F-86F. North American Aviation built a total of 1,959 F-86Fs at a fly-away cost of \$211,111.00 each. In addition to the North American total, Mitsubishi built another 300 F-86F-40s for the Japanese Air Self Defense Force. Strangely, the F-86F was not phased into Air National Guard service in great numbers. Most F-86Fs going into the MDAP inventory were sold to other nations.

TF-86F

To produce a two seat training variant of the Sabre, North American took a pair of F-86F-30s off the assembly line for conversion to two-seat TF-86F "transonic trainers." The fuselage was extended almost sixty-three inches and a second cockpit with full flight controls was added. The wing was also moved forward eight inches for increased stability and a very large clamshell-type canopy was fitted. The first TF-86F (52-5016) was finished in early December of 1953 and made its first flight on 14 December. Tests indicated that performance was nearly equal to that of a standard fighter F-86F.

The tests were cut short when the first TF-86F crashed on 17 March 1954 and the Air Force immediately authorized a second prototype. The second TF-86F (53-1228) was completed in August of 1954 and made its first flight on 5 August. The second TF-86F differed from the first in that it had underwing hard points for drop tanks or bombs. It also had a pair of .50 caliber machine guns in the nose for gunnery practice. The second TF-86F went through extensive testing before being delivered to the Fighter School at Nellis on 31 January 1955. In any event, it was never used in the training mission that it was developed for, mainly due to development of the TF-100 trainer. The aircraft was used at Edwards AFB Flight Test Center in the chase aircraft role well into the 1960s.

RF-86F

In Korea, reconnaissance missions were flown by a variety of aircraft types, from T-6s to RB-45Cs. Any mission flown into MiG Alley (or beyond) had to be flown by a fighter type aircraft to have any chance of survival. It did not take long for MiG pilots to realize

that a lone F-80 near the Yalu River was probably an unarmed RF-80 reconnaissance aircraft — an easy target for the MiG-15! FEAF and the crews with the 67th Tactical Recon Wing at Kimpo came up with the idea of modifying a Sabre to carry cameras for missions into MiG Alley.

Project ASHTRAY saw several older F-86As from the 4th FIW pulled from combat and sent to Tachikawa, Japan where FEAF mechanics removed their armament and installed a pair of K-24 cameras. Although the ASHTRAY conversions worked, improvements were needed. North American, under Project HAYMAKER, built several RF-86F conversions which were much more stable camera platforms. Some of these aircraft also retained a minimum defensive armament of two .50 caliber machine guns. Although only a handful saw service with USAF units, both the Japanese and South Korean air forces had squadrons of RF-86Fs in service.

CL-13A Sabre Mk 5 and CL-13B Sabre Mk 6

Canadair production of the F-86F series began with the CL-13A Sabre Mk 5. The Canadair CL-13A was not just a licensed copy of the F-86F since it was powered by the 6,355 lbst Avro Orenda 10 engine and incorporated the '6-3' wing with wing fences. The first Sabre Mk 5 was completed on 21 July 1953 and flown on 30 July. Canadair built a total of 370 Mk 5s, seventy-five of which were delivered to the Federal German Bundesluftwaffe. Many Canadair Sabres of all Mks were modified with British Martin Baker ejection seats in place of the standard North American seat.

The final Canadair-built variant was the CL-13B Sabre Mk 6. The Mk 6 was powered by the 7,275 lbst Orenda 14 engine making the Mk 6 the fastest Sabre variant, with a top speed in excess of 710 mph at sea level, a full 40 mph faster than the F-86A. Rate of climb was 11,800 ft/min, some 1,700 ft/min greater than the MiG-15. Initial production of the Mk 6 incorporated the '6-3' wing with fences, but the poor stall characteristics of the wing led Canadair engineers to replace it with a wide chord '6-3' wing with LES. Canadair production of the Sabre continued until 9 October 1958 when the last Sabre Mk 6 for West Germany came off the assembly line at Cartierville. It was the last of 655 Mk 6s and the 1,815th Canadair Sabre built.

























North American engineers pulled an F-86F-30 from the production line and stretched the fuselage sixty-three inches to make room for the second cockpit and moved the wing forward eight inches to restore the center of gravity. Fuselage Development

The TF-86F did not see much service in the mission for which it had been designed. The second TF-86F prototype, however, did see extensive duty at Edwards AFB as a chase aircraft where it served well into the 1960s. (Brian Baker)





Commonwealth CA-26/27 Sabre

The most radical license-built variant of the Sabre was the Australian Commonwealth Aircraft Corporation CA-26. The CA-26 mated an F-86F airframe with a 7,500 lbst Rolls Royce RA 7 Avon engine. Sounds simple enough but the installation required a number of airframe changes. Since the Avon engine consumed some twenty-five percent more air than the J47 engine, Commonwealth engineers had to split the forward fuselage and splice in an additional three inches to the air intake area. Although of a similar size dimensionally as the J47, the Avon was some 400 pounds lighter. This meant that the aircraft's center of gravity would be thrown off. To preserve the standard Sabre c/g, the Avon engine was positioned further back in the fuselage. Moving the engine also meant that the fuselage "break point" (where the forward and rear fuselage sections split for engine servicing) also had to be moved rearward.

The armament was also changed with the six .50 caliber machine guns being replaced by a pair of Aden 30MM cannons. The fuselage fuel cells and accessories were also relocated. By the time Commonwealth engineers had finished with the engine installation, only twenty-five percent of the original North American fuselage remained. The wing and tail section were retained from the F-86F, including the "all-flying tail," and the narrow chord wing with LES. The CA-26 prototype (A94-101) was completed in early July of 1953 and RAAF FLT LT W. Scott took the Sabre Mk 30 into the air for the first time on 3 August 1953.

Production aircraft were designated the CA-27 and received serials beginning with A94-901. The first CA-27/Mk 30 production aircraft was delivered on 19 August 1954 and following production of the initial batch, North American began shipping wings to CAC equipped with the '6-3' leading edge extension and wing fences. CA-27 Sabres with the '6-3' wing were designated as Sabre Mk 31s. All previous Mk 30 aircraft were later retrofitted with the '6-3' wing as they went through IRAN overhauls. The Mk 32 used the new CAC-built Mk 26 Avon engine and had provisions for underwing ordnance in addition to a pair of drop tanks (similar to the USAF F-86F-25/30). In 1959, the RAAF began fitting Sidewinder missile launch rails on these additional hard points. CAC built a total of 112 Avon Sabres between August 1954 and December 1961.

The first operational Avon Sabre unit was No 75 Squadron commissioned in April of 1955. The RAAF had a total of six Sabre units, five fighter squadrons and an operational conversion unit (OCU). RAAF Sabre units saw combat in the attempted communist takeover in Malaya in the late 1950s. Nos 3 and 77 Squadrons flew ground attack and counter-insurgency missions beginning in February of 1959, continuing until July of 1960. RAAF Avon Sabres were on a combat footing again beginning in 1962 when No 79 Squadron began an extended stay at Ubon RTAFB in Thailand. They would provide combat air patrols over Thailand during the early stages of the Vietnam War. As RAAF units converted to higher performance aircraft such as the Dassault Mirage III, the Avon Sabres were made available for sale. Malaysia received eighteen Avon Sabres during 1969 and 1971. Indonesia purchased eighteen Avon Sabres from the RAAF in February of 1973 and another five from Malaysia during July 1976.



Following their retirement from service with the RAAF, the Malaysian and Indonesian governments each purchased CA-27 Sabre Mk 32s from RAAF inventories. This Malaysian Air Force Sabre Mk 32 was camouflaged in Dark Green over Light Gray.





F-86H

The last Sabre variant built by North American was the F-86H and it was intended to be the best of the Sabre line. All the previous problems and "needs" were going to be answered with the F-86H. The additional power that Sabre pilots craved was answered by installing a 8,900 lbst General Electric J73 engine, which required a six inch increase in fuselage depth. The lack of fire power was greatly improved by replacing the six .50 caliber machine guns with four of the newly developed M39 20MM high speed cannons (although early production F-86H-1s retained the six .50 caliber gun armament). The F-86H initially had the '6-3' wing with fences, but was later fitted with the F-40 extended wing and eventually all production F-86Hs were retrofitted with the F-40 wing. The F-86H was equipped with the LABS system and could carry a 1,200 pound "special store" (atomic weapon) on the inboard underwing hard points.

Unfortunately, the airframe itself had reached its limit and no amount of additional power could bring the F-86H into the level supersonic speed range. That fact, plus development of the "Sabre 45" (F-100 Super Sabre), led to a short production run of only 473 aircraft (at a flyaway cost of \$582,839.00 each). Although both of the prototypes (52-1975 and 52-1976) were built at the Inglewood North American plant, all production aircraft were built at the North American plant in Columbus, Ohio. The first production aircraft were delivered to the 312th FBW at Clovis AFB, NM in the Fall of 1954 while the last F-86H was delivered to the Air Force in October of 1955. F-86Hs equipped five USAF

fighter-bomber wings in the mid-1950s.

The first F-86H aircraft were already being phased into Air National Guard service by 1957 and by June of 1958, all F-86Hs in active Air Force use had been passed to the ANG, although there was a brief time when a number of the F-86Hs were returned to active duty. During the 1961 Berlin Crisis, the Air Force activated the 101st and 131st Tactical Fighter Squadrons, Massachusetts Air National Guard, deploying them to Phalsbourg Air Base, France where they remained until August of 1962.

It was an F-86H that flew the final USAF/ANG Sabre sortie, when the 138th TFS, New York ANG phased the Sabre out of service on 30 September 1970. Following phaseout with the Air National Guard, the F-86Hs with the lowest flight hours were made available to the U.S. Navy. The Navy had a dual use for the Sabres — as a target drone and as a MiG simulator in air combat training. F-86Hs were used in the Navy TOP GUN program as an aggressor aircraft since they were of a similar size, shape and performance as the MiG-17s being encountered by Navy pilots over North Vietnam. More than one Navy TOP GUN F-4 pilot was "killed" by a Sabre. Finally, the F-86Hs were used as target drones for testing advanced air-to-air and surface-to-air systems such as the Phoenix. AMRAAM, and Standard missiles.





F-86K

Another major development in the Sabre line was the Fiat of Italy license-built F-86K. The F-86K model was the answer to a NATO requirement for an all-weather jet interceptor to counter the Soviet nuclear bomber threat. Basically the F-86K was an F-86D simplified for use by NATO and other friendly foreign air forces. The F-86K was armed with four M24A 20MM cannons in place of the all-rocket armament of the F-86D. The F-86K also used an MG-4 Fire Control System with an optical gunsight in place of the much more sophisticated Hughes E-4 system found on USAF aircraft and the F-86K retained the AN/APG-36 search radar used with the F-86D.

Initially, the F-86K was to have followed all the engine changes found in the F-86D program. The Air Force, however, wisely decided to use a single power plant, the J47-GE-33 for all the F-86Ks, simplifying production. As with the F-86D and F-86L, the F-86K had the early narrow chord wing with leading edge slats, but was later retrofitted with the F-40's extended wing. Finally, many F-86Ks had their armament upgraded to include a pair of Sidewinder air-to-air missile in addition to their four cannons.

The first flight of the YF-86K prototype took place on 15 July 1954. Both YF-86Ks were converted F-86D-40 airframes (52-3630 and 52-3804). Following service tests at Edwards AFB, both YF-86Ks were delivered to Fiat in Italy. North American built 120 F-86Ks at the Inglewood plant, which were then disassembled and shipped to Fiat for assembly, while Fiat built another 221 F-86Ks.

The first F-86Ks went into service with the 1st *Aerobrigata*, Italian Air Force in the late Summer of 1955. NATO air forces that operated the F-86K included the Italian, French, Federal German, Dutch and Turkish air forces. Phaseout of the F-86K began during 1964 when Italian Air Force units began to transition to the Lockheed F-104 Starfighter.


The F-86K was the North American Aviation answer to a NATO requirement for a gun armed all-weather interceptor. Basically the F-86K was an F-86D-45, with a less sophisticated MG4 Fire Control System and four cannon armament. (USAF)







Armament Development

Korea

Any conversation regarding the Sabre automatically leads to the subject of Korea, for it was over Korea that the Sabre proved its mettle. What makes the topic even more interesting is that in almost every aspect of air combat with the MiG-15, the Sabre was never its equal — yet the results of that Police Action revealed at least a 10-1 kill ratio in favor of the Sabre.

A comparison of the performance characteristics of the MiG-15 and the Sabre are extraordinary when viewed in the results of the war. The MiG was much smaller and lighter, weighing slightly over 11,000 pounds, compared with the F-86E at 19,000 pounds. The MiG was powered by a Soviet copy of the Rolls Royce Nene engine, the 5,000 lbst RD-45, while the F-86F had the most powerful Sabre engine with 5,910 lbst. The MiG and Sabre were roughly comparable in top speed at both sea level and at combat altitudes of 40,000 feet or above. But the lighter weight of the MiG gave it a phenomenal rate of climb of over 10,000 ft/min. The F-86F with the -27 engine could muster 9,300 ft/min; however, the Sabres that met and defeated the MiGs in 1950-52 were mostly F-86As and F-86Es, both of which had a rate of climb of only 7,400 ft/min.

The lightweight MiG also had about a 7,000 foot advantage in service ceiling. Sabres in Korea were entering MiG Alley at 45,000 feet only to find the MiGs were about 10,000 feet above them — and there was nothing the Sabre pilots could do about it unless the MiGs came down. If they did come down, their advantages started fading rapidly. The Sabres being much heavier than the MiGs, had a much higher diving speed. Both the Sabre and MiG could go supersonic in a dive, but the Sabre was a much more stable aircraft in the transonic speed range. The MiG-15 became quite unstable when entering the transonic speeds near Mach one. It was not uncommon for a Sabre pilot to push a MiG pilot into the transonic speed area only to see the MiG lose the entire vertical tail assembly during violent combat maneuvering. The MiG was a much more maneuverable aircraft than the F-86A, F-86E and early F-86F. But the later F-86F with the hard wing leading edge and wing fences erased that advantage.

Armament was a tie with neither having a clear advantage. The MiG had much greater hitting power with its twin 23MM cannons and single 37MM cannon. But the cyclic rate of these guns was very slow and their ammunition supply was low: 160 rounds per gun for the 23MM guns and forty rounds for the 37MM gun. The F-86s were armed with six .50 caliber machine guns. The machine guns had a much higher cyclic rate, could carry much more ammunition, but did not have the stopping power of the cannon. It was not unusual for a Sabre pilot to empty all 1,600 rounds into a MiG, only to have the MiG escape back over the Yalu. The Sabre did have a radar-ranging gunsight, which was far more accurate than the older gyroscopic sight in the MiG. This accuracy, however, was wasted due to the low weight of fire from the six .50s. Add to all this the fact that the Sabre flights were always outnumbered and were flying at the extreme end of their range. Communist MiG strength ran between 400 and 500 MIGs in early 1951, to over 1,000 MiGs by the end of the war. This was opposed by a single squadron of F-86As in 1951, to six squadrons in early 1953 and finally eleven squadrons at the end of the war.

So how did we end up with that extraordinary kill ratio? The answer is simple — the pilots! The pilots of the 5th Air Force were much better trained than the best the Communists sent to Korea. Most of the Sabre pilots, especially the squadron and group commanders, had extensive combat experience in the Second World War. Although the Russian pilots that flew in Korea had some combat experience, most of the North Korean and Chinese pilots had none. All this Second World War experience meant that the Sabre pilots had already developed and proven the combat tactics they would be

using in Korea. Tactics that had worked against a much better foe six years earlier.

The most important ingredient that brought success to the Sabre pilots was their aggressiveness in combat. Where a MiG pilot might be wary of combat, the Sabre pilots were looking for it. As the Navy ads say, "It's not just a job." Always outnumbered in MiG Alley, Sabre pilots never hesitated to join combat with the MiGs — no matter what the odds were. One Sabre pilot once exclaimed over the radio that, "I have 24 MiGs cornered near Sinanju in case anyone isn't busy!" It was that type of aggressive attitude that gave the combat edge to the Sabre pilots. Add to all this the technological advances made to the Sabre airframe and systems, advances that the Sabre pilots always took full advantage of, and one can now begin to see how the 10-1 victory margin came about.


The seven F-86As that LCOL Bruce Hinton took to K-14 on 13 December 1950 all had the short-chord wing with LES, a gyroscopic gunsight, standard tail and the 5,200 lbst-13 engine. Yet they wrestled control of the skies over North Korea from the MiGs in one afternoon. By the time the F-86F-25 arrived with its improved wing, radar-ranging gunsight and more powerful engine, Sabre pilots had total air supremacy all the way to the Yalu River and beyond! At the end of the war, the final score was amazing. The final score was 792 MiGs shot down by F-86s, for a loss of 78 Sabres to the MiGs — a 10-1 victory margin. It was the greatest victory margin of any U.S.-involved conflict, excluding the latest confrontation in the Gulf. The phenomenal victory margin was the result of putting a superbly trained, aggressive pilot into a superbly designed and developed fighter aircraft, using combat tactics developed by proven combat leaders. Although the war in Korea officially ended as a tie, the skies belonged to the Sabre Pilots!


